A Bill

Make Appropriation for 14 organizations

Be it enacted by the legislative assembly of the Youngstown state university student government association assembled, that the following sums are appropriated, out of any money in the appropriations fund not otherwise appropriated, for the fiscal year ending June 30th, 2018 for the following activities of student organizations:

Section 1: *Beta Gamma Sigma*, is appropriated the sum of \$800 from the general fund and \$300 from the Chartwells fund to defray the cost of catering for the Case Competition event held on October 27, 2018. This event will be held at Williamson Hall. Sixty (60) students are expected to attend the event.

Section 2: *Networking for tennis Enthusiasts*, is appropriated the sum of \$200 from the NSOF for startup costs.

Section 3: *YSU Campus Crusade for Christ (Cru)*, is appropriated the sum of \$850 from the general fund to defray the cost of registration and hotel for their Fall CruCleveland Retreat on October 26, 2018 thru October 28, 2018.
