Be it enacted by the Legislative Assembly of the Youngstown State University Student Government Association assembled, that the following sums are appropriated, out of any money in the Appropriations Fund not otherwise appropriated, for the fiscal year ending June 30th, 2022, for the following activities of student organizations:

Section 1: Theta Chi Fraternity is appropriated the sum of \$290 from the general fund to defray the cost of a dunk tank rental, water, and a plaque for their "G.I Theta Chi" event being held on October 18th, 2021 thru October 22nd, 2021 at the Kilcawley Center on YSU's Campus. A Bill

Make appropriations for 11 organizations

Be it enacted by the Legislative Assembly of the Youngstown State University Student Government Association assembled, that the following sums are appropriated, out of any money in the Appropriations Fund not otherwise appropriated, for the fiscal year ending June 30th, 2022, for the following activities of student organizations:

Section 1: *YSU Computer Club* is appropriated the sum of \$1,050 from the Chartwells fund to defray the cost of food for their "HackYSU 2022" event being held on April 8th, 2022 thru April 10th, 2022 at the DeBartolo Stadium Club on YSU's campus. Approximately one hundred (100) people are expected to attend the event.

Section 2: *YSU Executive Board for Club Sports* is appropriated the sum of \$552 from the Chartwells fund to defray the cost of catering for their "Club Sports Awards" event being held on April 14th, 2022 at the Chestnut Room in Kilcawley Center on YSU's campus. Approximately sixty (60) people are expected to attend the event.

Section 3: *YSU Tennis Club* is appropriated the sum of \$1,956 from the general fund to defray the cost of an entry fee, a hotel, car rentals, and gas for their "Spring 2022 Club Tennis Tournament" event being held on April 23rd, 2022 thru April 24th, 2022 at Western and Southern's Linder Family Tennis Center. Approximately eight (8) students are expected to participate in the event.

Section 4: *International Student Association* is appropriated the sum of \$670 from the general fund to defray the cost of colors, DJ costs, and water for their "Holi (Festival of Colors)" event being held on April 16th, 2022 at Cafaro Lawn on
